

# 2021 MPMCA/ASSE Backflow Recertification

## RECERTIFICATION TESTING

- **For those who hold ASSE certification and need to be recertified**

The 2021 dates for the **Backflow Preventer Recertification's** are:

**Jan. 11, 2021**

**April 19, 2021**

**July 19, 2021**

**Oct. 18, 2021**

Each class will be limited to 20 students. On the application form you can pick your first, second, and third choice. First choice will be determined on a first received basis.

The cost will be **\$385.00 for MPMCA Members** or **\$645.00 for Nonmembers**. Cost includes the testing materials you will need for the practical portion, (be sure to bring something to write with).

The location will be the **MPMCA Backflow Class, 1120 Commerce Park Drive, Suite B, DeWitt, MI 48820 Exit 87 off I-69** in Lansing. If students would like to stay at the hotel the night before the class, the rate is \$72.00+ applicable tax per night, single or double occupancy. **Hotel information will be emailed with confirmations that will be emailed 3 to 4 weeks before the class.**

Instructors and proctors are Martin Jipson and Phyllis Centers.

**This Class is only for those individuals who currently hold a ASSE Backflow Certificate which requires recertification every three years.** You must recertify prior to the expiration date on your current certification card. Be sure to check the date of expiration.

**If you have taken one of MPMCA's Backflow courses previously, MPMCA will contact you via the email you gave us in your original class prior to your expiration date notifying you when you need to recertify along with this registration form.**

**MPMCA maintains a certified backflow test list** for the State of Michigan which is updated daily on the MPMCA website. Check for your name and expiration date at [www.mpmca.org/backflowsearch](http://www.mpmca.org/backflowsearch) .

**Final Examination of Proficiency Required for Certification** which consists of a 25-question written examination and passing the practical portion as you did in the original class. **BE SURE TO REVIEW THE MATERIALS YOU RECEIVED FROM YOUR ORIGINAL CLASS PRIOR TO ATTENDING THIS CLASS.** Come with any questions you may have, and they will be addressed before the exam.
