

# FOR INDIVIDUALS WHO CURRENTLY HOLD AN MPMCA BACKFLOW CERTIFICATION

## THE **LAST OF THE MPMCA ASSE APPROVED** TWO-DAY BACKFLOW CERTIFICATION UPGRADE COURSES

- Your current MPMCA Backflow certification can be upgraded upon successful completion of this ASSE Approved **TWO-DAY** class. For those who have successfully completed MPMCA's three-day class and now want to take advantage of the ability to upgrade their certification to ASSE/MPMCA Certification.

The **LAST OF THE TWO-DAY UPGRADE CLASSES** are in 2018. The dates for the two-day Backflow Preventer Recertification classes are:

**Jan. 15 & 16, 2018 and April 23 & 24, 2018,**

Each class will be limited to 20 students. On the application form you can pick your first, second, and third choice. First choice & class placement will be determined on a first received basis.

The cost will be **\$650.00 for MPMCA Members** or **\$905.00 for Nonmembers**. This will include all books & the materials you will need for testing. Be sure to bring something to write with.

The location will be the **MPMCA Backflow Class, 1120 Commerce Park Drive, Suite B, DeWitt, MI 48820 Exit 87 off I-69** in Lansing. If students would like to stay at the hotel the night before the class, the rate is \$66.00+ applicable tax per night, single or double occupancy. Hotel information will be mailed with confirmations that will be mailed 4 weeks before the class.

**Instructors and proctors for the class are Martin Jipson and Phyllis Centers.**

In order to upgrade your certification to the MPMCA/ASSE certification you must **currently** hold an MPMCA Backflow Certification card **and** requires applicants to have five years' experience in a plumbing, pipefitting, lawn irrigation, water purveyor, sprinkler installer, or related field. The instructor will begin the class at a level that requires all applicants to have been using your Backflow skills within the past 3-5 years.

**Final Examination of Proficiency Required for Certification** which consists of a 50 question multiple choice written examination and proper testing of an ASSE 1013, ASSE 1015, ASSE 1020, and ASSE 1056 without the guides. Working knowledge and practice is suggested prior to attending. **If you are filling this out and not the person attending, please be sure to go over the testing requirements with them**

**Under Act 54** - Plumbing Inspectors Registration Act - Plumbing Inspectors will receive 10 specialty and 4 technical CEU credits.

**Water Purveyor Participants** receive 0.4 continuing education credits under the Michigan Department of Environmental Quality advisory board approved education credits.
